REQUIREMENTS

- Attendance in the classroom portion is mandatory. Absolutely NO absences are allowed.
- A copy of the student's learner's permit must be submitted with payment and completed contract.

The cost of the Driver's Education course, at Peachtree Ridge Community School, part of the Gwinnett County School System, is **\$345**. This fee includes 30 hours of classroom instruction, 6 hours of road instruction (after class instruction completed), and 6 hours of in car observations. Each student receives a certificate if a grade average of 70 or above is earned and when all 36 hours of instruction are completed. Additional road instruction can be arranged for a fee of \$45 per hour for students. Certificate replacement is \$5.00.

It is the responsibility of the parents to provide transportation for the student to and from the Driver's Education classes and Driving appointments located at Peachtree Ridge Community School at 1555 Old Peachtree Road, Suwanee, GA 30024. The telephone number is 678-512-6040. The completion of the course does not in any way, directly or indirectly, imply that the student will receive his/her driver's license from the State of Georgia or any other state.

Notification of cancellation must be received within 2 weeks prior to the start of the class in order to receive a full refund. No refunds are given once the class has begun. If the student fails to appear for a pre-scheduled driving appointment, a fee of \$30 will be charged. This fee must be paid before the student is rescheduled. The student has 90 days from the last day of the classroom portion to complete the driving portion unless pre-arrangements have been made.

The Community School's liability insurance follows the car and provides the maximum coverage possible (\$500,000/person/accident/property). Parents and/or guardians of students are not permitted, by DDS mandate, to accompany their student during his/her 6 hours of road instruction. Each instructor is certified by the DDS. Berkmar High Community School is licensed by the DDS in accordance with Title 43-13-1. A performance bond of \$10,000 has and will be maintained for the protection of the contractual rights of the students.
