REQUIREMENTS

- A COPY OF THIS CONTRACT and STUDENT LEARNER'S PERMIT MUST BE TURNED IN NO LATER THAN ONE WEEK PRIOR TO THE FIRST DAY OF CLASS.
- Attendance in the classroom portion is mandatory. Absolutely NO absences are allowed. Students that are absent are required to drop the current class and transfer to the next class offered.

The cost of the Driver's Education course at Parkview Community School is **\$345**. This fee includes 30 hours of classroom instruction and 6 hours of road instruction (after the class instruction is completed). Each student receives a certificate if an exam grade of 70 or above is earned and when all 36 hours of instruction are completed. Additional road instruction can be arranged for a fee of \$45 per hour. Certificate replacement cost is \$5.00.

It is the responsibility of the parents to provide transportation for the student to and from the Driver's Education driving appointments located at Parkview Community School. The completion of the course does not in any way, directly or indirectly, imply that the student will receive his/her driver's license from the State of Georgia or any other state.

Notification of cancellation must be received within 4 business days prior to the start of the class in order to receive a full refund. No refunds are given once the class has begun. The lessons may be forfeited if the student does not attend the classroom portion or neglects to notify the driver education instructor at least 48 hours in advance that he/she is not able to drive during the assigned time. There will be a \$45 rescheduling fee if a student fails to report for a scheduled driving appointment. The student has 90 days from the last day of the classroom portion to complete the driving portion unless pre-arrangements have been made.

The Community School's liability insurance follows the car and provides the maximum coverage possible (\$500,000/person/accident/property). Parents and/or guardians of students who operate a Gwinnett County Public Schools' driver's education vehicle may incur personal liability in some driver-at-fault accidents. Each instructor is certified by the DDS and in accordance with Title 43-13-1. The school is also bonded in the amount of \$10,000 and it will be maintained for the protection of the contractual rights of the students.
